EDITORIAL

It is with great pleasure that we present the first issue of the journal Caderno de Direito e Pública Policias (CDPP) (vol.1, n.1, 2019) to the academic community, researchers, students and others interested in participating in a plural and contemporary debate that involve in an inter and multidisciplinary way the themes associated with public policies.

This initiative was taken after we envisioned an opportune moment for the maturation of the UNIRIO Postgraduate Program in Law, constituted around an area of concentration: State, Society and Public Policy with its two lines of research: 1) State, Constitution and Public policy; 2) Law, Public Policy and Sustainability.

We must also recognize that it is a major challenge to integrate the specific knowledge derived from each of the areas that make up the Program under the theme of Public Policy.

In order to advance academic and scientific dissemination, we innovated by opening up to a plural and integrated production, in an effort on the one hand of scientific articles by doctoral professors, and on the other the production of master's students, with the creation of a thematic section, in order to stimulate the academic publishing activity of the students of all the Programs that want to participate. In this first issue, the thematic section is about the financing of public policies in Brazil.

The challenges of making room for discussion in the idea of an information exchange are set! There is no doubt that this task requires dialogue, reflection of praxis and constant evaluation in order to contribute to the process and the desired ends.

It is in this context that the journal in its vl.1 offers nine articles that present the main points about the effectiveness of judicial decisions in conflicts involving public policies, as well as the administrative process of urban land regularization, the formation procedure of the real estate consortium, reflections on the human rights of adolescents apprehended in DEGASE, a legal analysis of the reception of federal funds, and democratic management and democracy and participatory in public policy. From the uniqueness of each, although inserted in an interdisciplinary field, they were organized according to the thematic approach.
